

SUPPLEMENTAL WAGE AGREEMENT
TO THE
AGREEMENT BY AND BETWEEN THE BOARD OF TRUSTEES OF THE
UNIVERSITY OF ILLINOIS AND LOCAL UNION # 26 OF
THE INTERNATIONAL BROTHERHOOD OF TEAMSTERS,
CHAUFFEURS, WAREHOUSEMEN, AND HELPERS UNION

WHEREAS THE BOARD OF TRUSTEES OF THE UNIVERSITY OF ILLINOIS AND LOCAL UNION #26 OF THE INTERNATIONAL BROTHERHOOD OF TEAMSTERS, CHAUFFEURS, WAREHOUSEMEN, AND HELPERS UNION, entered into a Labor Agreement effective August 19, 2001 through August 27, 2005 and;

WHEREAS Article X, Section 2 of the parties' Agreement provides, in part, ". . . the Union may reopen this Agreement for the sole purpose of negotiation of hourly rates for years two (2), three (3), and four (4) of this Agreement as follows:

Year 2 – September 1, 2002 through August 30, 2003
Year 3 – August 31, 2003 through August 28, 2004
Year 4 – August 29, 2004 through August 27, 2005

WHEREAS the University of Illinois and the Union negotiated and agreed to a three percent (3%) salary increase for the International Brotherhood of Teamsters, Chauffeurs, Warehousemen, and Helpers Union, Local 26's bargaining unit for year four, effective August 29, 2004

NOW THEREFORE it is agreed as follows:

Hourly wage rates effective August 29, 2004 will be as specified on Appendix "A" to this Supplemental Wage Agreement, attached thereto and a part hereof.
