

SUPPLEMENTAL WAGE AGREEMENT
TO THE
AGREEMENT BY AND BETWEEN THE BOARD OF TRUSTEES OF THE
UNIVERSITY OF ILLINOIS AND LOCAL UNION NO. 601 OF
THE INTERNATIONAL BROTHERHOOD OF ELECTRICAL WORKERS, AFL-CIO

WHEREAS THE BOARD OF TRUSTEES OF THE UNIVERSITY OF ILLINOIS AND
LOCAL UNION NO. 601 OF THE INTERNATIONAL BROTHERHOOD OF ELECTRICAL
WORKERS, AFL-CIO,

entered into a Labor Agreement effective August 26, 2007 through August 22, 2009 and;

WHEREAS Appendix A, of the parties' Agreement provides, in part,
"For the remaining year of this Agreement, it is hereby agreed by both parties to this Agreement that wages will be adjusted on August 24, 2008 by the percentage increase announced by the University of Illinois Urbana-Champaign campus to the General Salary Policy for Civil Service Employees. In the event the increase is less than 2.5% (two and one-half per cent) the Union is entitled to request a re-opener to discuss wages."

WHEREAS the University of Illinois and the Union negotiated and agreed to a two percent (2%) salary increase for the International Brotherhood of Electrical Workers, AFL-CIO, Local 601's bargaining unit for the remaining year of the Agreement, effective February 8, 2009

NOW THEREFORE it is agreed as follows:

Hourly wage rates effective February 8, 2009 will be as specified on Appendix "A" to this Supplemental Wage Agreement, attached thereto and a part hereof.
