WHEREAS, THE BOARD OF TRUSTEES OF THE UNIVERSITY OF ILLINOIS AND LOCAL NO. 698 OF THE AMERICAN FEDERATION OF STATE, COUNTY, AND MUNICIPAL EMPLOYEES entered into a Labor Agreement effective August 24, 2009 through August 21, 2010 and;

WHEREAS, Article VIII, Section 3 of the parties' Agreement provides,

Basic straight time hourly rates for employees covered by this Agreement are and shall be as set forth in Appendix "A", attached hereto and made a part hereof by this reference.

WHEREAS the University of Illinois and the Union negotiated and agreed to a one dollar (\$1.00) per hour salary increase for current employees classified as Staff I nurses, of Local # 698 of the American Federation of State, County, and Municipal Employees bargaining unit effective February 22, 2009.

NOW THEREFORE, it is agreed as follows:

Hourly wage rates effective February 22, 2009 will be as specified on Appendix "A" to this Supplemental Wage Agreement, attached thereto and a part hereof.
